

# Terms of Service for PromptBand

**Effective date:** December 26, 2025

These Terms of Service ("Terms") govern your use of the PromptBand ChatGPT application ("PromptBand", "we", "our", or "us"). By using PromptBand, you agree to these Terms.

## 1. The service

PromptBand provides a tool that generates MusicXML notation or tablature based on music-related input you provide. Outputs are generated from the input you submit and are intended for creative and educational use.

## 2. Eligibility

You may use PromptBand only if you are permitted to use ChatGPT and are able to form a binding agreement in your jurisdiction. If you are using PromptBand on behalf of an organization, you represent that you have authority to accept these Terms on its behalf.

## 3. Acceptable use

You agree not to:

- Use PromptBand in a way that violates any applicable law or regulation
- Attempt to reverse engineer, disrupt, or overload the service or its underlying systems
- Use PromptBand to transmit malware, spam, or harmful code
- Misrepresent the origin of outputs or use the service to deceive others about authorship or rights

## 4. Your content and permissions

You are responsible for the content you provide as tool input (for example, musical ideas, note sequences, or chord progressions). You represent that you have the rights necessary to submit that content and to use the outputs you request.

As between you and PromptBand, you retain any rights you may have in your tool input. PromptBand does not claim ownership of your tool input. PromptBand provides the MusicXML output you request; however, similar or identical outputs may be generated for other users based on similar inputs.

PromptBand's handling of information is described in our Privacy Policy. In general, PromptBand processes only the data you pass to the tool to generate MusicXML.

We may modify, suspend, or discontinue PromptBand (in whole or in part) at any time. We may also update these Terms from time to time. The effective date above will reflect the latest version.

PromptBand is provided "as is" and "as available" without warranties of any kind, whether express or implied, including implied warranties of merchantability, fitness for a particular purpose, and non-infringement. We do not guarantee that the service will be uninterrupted, error-free, or that outputs will be accurate or suitable for any specific use.
